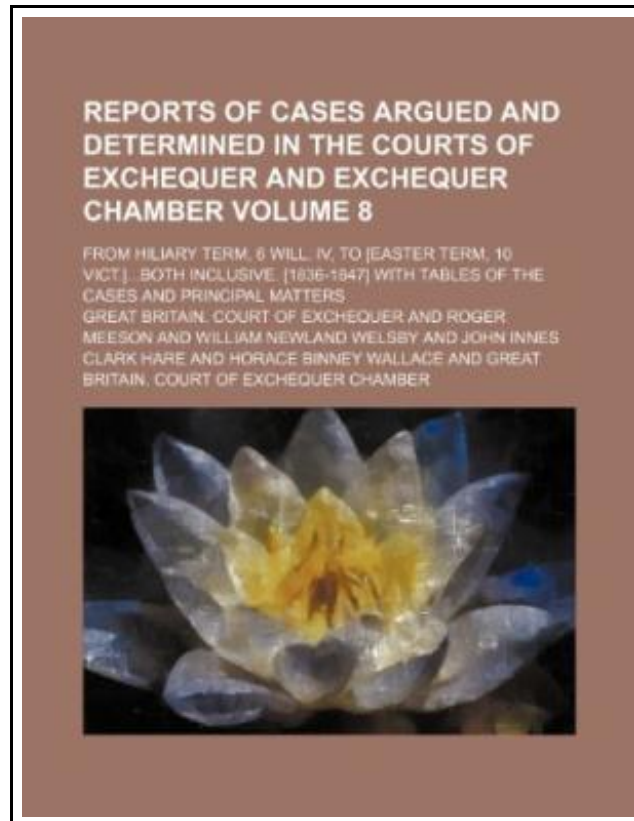

The other part of the breach is, and did not then and there prosecute, c. Parke, B.--Would not that be double? No; in Phillips v. Price, 3 M. Selw. 180, it was held that a declaration by the assignees of a replevin bond, conditioned for prosecuting the suit with effect, and for making a return of the goods, was not double, because it alleged that the defendant did not prosecute his suit with effect, and had not made a return. The effect of the breach here is, that he did not appear, and it is sufficient to prove any part of the breach: Short v. Hubbard, 2 Bing. 349. There is no demurrer on the ground of duplicity. Where there is an obligation conditioned to do several things, the obligation is forfeited on the breach of one: Tumor v. Turner, 2 B. B. 107. Here three things are required to be done, and a breach of any one of them is sufficient, and in effect the breach here is, that the defendant did not do either of them. In Dias v. Freeman, 5 T. R. 195, the breach was that the defendant did not appear at the County Court next after the...
