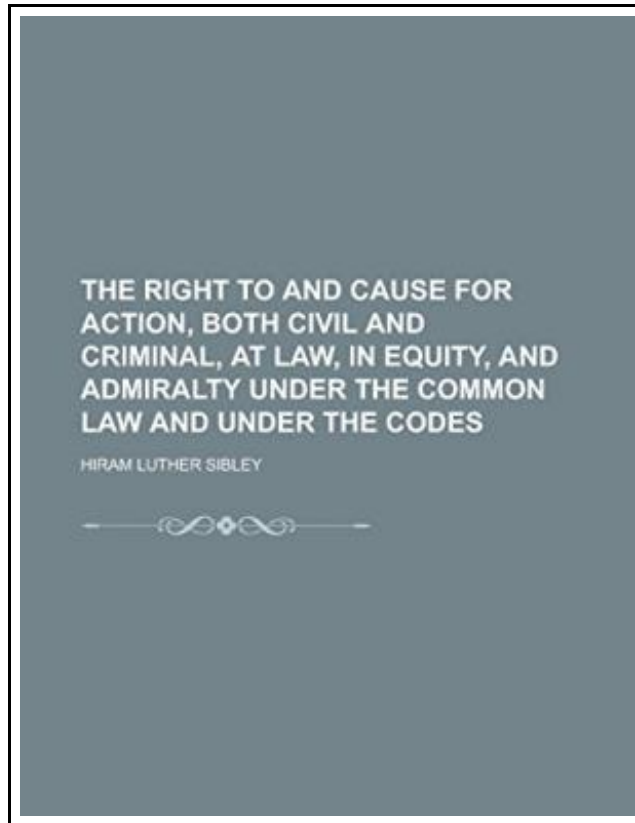

Upon the question thus made, the action went to the court of appeals. With respect to jurisdiction, the Code provided. that cases should be tried in the county where the cause of action or some part of it arose. The contention of the plaintiff was, that as the debt had been made in the county where he began his suit, a part of the cause arose there, and. therefore it was well brought. The court, however, held otherwise. In the opinion they say: The statute imposes upon the officers of such a company, as a penalty for a false report, liability for the debts of the company., This cause of action arose in Monroe County.-The false report was there made and filed, and the penalty there incurred. The learned counsel for the plaintiff, however, claims that, as the debt against the company had its origin in St. Lawrence County, some part of the cause of action arose there. But the defendant was not primarily liable for that debt. He did not create it, or in any way obligate himself to pay it. The cause of action against him is the false report, and nothing else.
